I am afforded 10 days of academic leave per year and additional vacation leave to fulfill these obligations

What talents and skills do you bring to the Residents Forum Executive Committee that you believe would benefit the Residents Forum?

- I have experience with public speaking in a professional organizational setting I performed a USCAP platform presentation at this past year's conference in Boston on SOX11 expression in ETV6::NTRK3 fused infantile fibrosarcoma.
- I am not afraid to speak up regarding uncomfortable topics I passed legislation advocating for sexual assault victims in my undergraduate Student Association Senate; I am spear-heading a new GME-wide social program addressing burnout among residents and fellows as a Wellness Committee member.

- I am passionate about creating a safe environment in which residents feel that they can communicate their needs and concerns I have experience as a Lead Peer Mentor in medical school and as a Memphis Crisis Line operator with 988 Lifeline certification.
- I have experience acting as a liaison as a resident liaison for the UTHSC COM Pathology Student Interest Group, and as a liaison between laboratory staff and faculty in forming a resident manual for our surgical pathology program.
