Working for free: Denial trends

- Prior Authorization denials (some are for procedures not requiring pre-cert)
- Large claims "Smoke & Mirrors" denials
- ID Card mismatch denials
- Medically Unlikely Edits and Flags for utilization review

Ask about	Ask about results of coding audits so that you can generate reports that are more reflective of the wo
Ask	Ask your practice management team if there are any denial trends affecting your practice and if there document better to improve the process or perform differently to meet reasonable standards
Get	Get to know your non-pathology clinical colleagues and administration
Be	Be involved with your state pathology society
Hark	Hark the call of advocacy alerts
Consider	Consider talking to your local congressperson as an intro to the work you do
