Whether mentoring premedical students or representing the interests of residents at a national level, I've embraced leadership as a principle towards becoming an advocate for the needs and perspectives of fellow residents. In the role of preceptor for the premedical summer program, I've engaged in cultivating leadership skills among aspiring doctors. By supporting the professional development of future pathologists, I've guided them through hands-on experiences, boosting their confidence and competence in pathology. Additionally, my role as the CAP Resident Forum delegate involved effective communication and advocacy, as I've conveyed co-residents' concerns and presented resolutions to the CAP House of Delegates. I have also actively engaged participants in case-based learning activities focusing on Patient Safety and Quality Improvement (PSQI), professionalism and supervision. What do you hope to accomplish during your time, if elected?

Based on my previous experiences, I am committed to addressing residents' concerns, promoting educational excellence, and upholding values of integrity, collaboration, and compassion. If elected to the RFEC, my primary goals would center around enhancing leadership, well-being, collaboration, and professional development among trainees. Firstly, I would prioritize the development of leadership skills by organizing a series of workshops tailored to address the unique challenges faced by trainees. These workshops would focus on effective communication, conflict resolution, team building, and mentorship strategies, providing practical tools that trainees can apply to their clinical environments. Promoting the well-being of trainees would be another crucial goal. I would implement initiatives such as mindfulness sessions, stress management workshops, and wellness challenges to enrich a culture of self-care. Additionally, I would ensure trainees have access to counseling services in their institutions, ECFMG resources and peer support groups to support their mental and emotional well-being. opportunities. These platforms would enable the exchange of best practices, enhancing the overall training experience. Lastly, I would focus on offering professional development opportunities. I would empower trainees to enhance their teaching skills and explore new approaches to medical education. Investing in their development as educators will enable them to make meaningful contributions to the advancement of pathology training and patient care.

The RFEC members hold crucial roles in guiding and representing the RF and ensuring effective communication and engagement within CAP. Their responsibilities extend across leadership, administration, representation, communication, and digital strategy, all of which contribute to the goals of networking, education, discussion, and action.

The RFEC members play a vital role in ensuring that the RF functions effectively, advocates for residents' interests, and facilitates meaningful engagement within the CAP and the broader medical community through AMA. All RFEC members carry general responsibilities to facilitate networking opportunities among residents and CAP members through meetings, provide informational presentations on relevant topics and updates on CAP and AMA. Moreover, their role is not limited to only facilitating forums and breakout sessions for residents to discuss issues, share challenges, and brainstorm solutions, but also take actions by applying initiatives.

Furthermore, each member has specific roles to fulfil during their term. For instance, the Chair, as the principal officer, leads meetings, maintains order, appoints committees. Additionally, the Chair demonstrates effective communication to keep CAP members, CAP membership committee, and the CAP Board of Governors informed about RF activities. In addition to communication, the Chair transmits RF resolutions and actions to the House of Delegates. The Vice Chair assists the Chair in duties and acts as the principal officer in the Chair's absence.

The secretary carries administrative duties of recording meetings, maintaining lists of delegates and committee members, preparing presentations, and handling credentialing. On the other hand, the delegate and alternate delegate to AMA represent advocacy, attend AMA meetings, present RF resolutions, and keep CAP informed about AMA activities.

Delegate and alternate delegate to the CAP House of Delegates has both advocacy and communication roles required to attend CAP House of Delegates meetings, present RF resolutions, and inform about RF activities. On the contrary, member-at-Large main responsibility is to assist in recruiting junior members and facilitates communication between CAP and its junior members. And lastly, digital strategy liaison partners with the CAP digital team to enhance RF's digital and social media imprints.

The role of the Vice Chair of the RFEC demands significant dedication, organization, and time management. Understanding this commitment's nature and the role of assisting the Chair, I am confident in my ability to meet this asking position. My previous and current experiences have equipped me with the necessary skills to manage these responsibilities effectively.

Considering the RFEC requirements, which include travel commitments, the Vice Chair position requires attending several in-person meetings throughout the year. Specifically, 4 times annual committee meetings, one spring and fall RF meetings, an annual CAP policy meeting and AMA Meetings.

I have demonstrated my capacity to manage travel and intensive schedules through various roles. For instance, as a facilitator in GME at Baylor College of Medicine, I have been actively involved in case-based learning activities that often require preparation and coordination beyond regular hours. My ability to engage and manage these activities demonstrates my readiness for the travel commitments of the RFEC Vice Chair role.

Besides travel, as a member of the RFEC, the Vice Chair must handle non-travel responsibilities that are required to be fulfilled. These commitments include monthly committee conference and committee chair calls, committee preparation, and reviewing meeting agenda.

My experience as a CAP RF delegate has honed my skills in communication and advocacy. Presenting

resolutions to the CAP House of Delegates requires meticulous preparation, like those needed for RFEC tasks as Vice Chair. Additionally, coordinating the PathArt contest involved planning, judging submissions, and collaborating with peers, mirroring the organizational skills necessary for reviewing meeting agendas.

Commitment and time management are also demonstrated in my current role as a pathology resident at Baylor College of Medicine. I have balanced multiple roles that require significant time and effort including facilitator for GME, preceptor for premedical summer program, course Lecturer for the PA program and member of residency selection committee. These roles have taught me effective time management and prioritization, enabling me to handle extensive commitments simultaneously. These experiences allow me to contribute diverse insights and approaches to medical education and patient care, enriching the committee's understanding and strategies.

During my current training at Baylor College of Medicine (BCM), I took part of graduate medical education's (GME) orientation sessions and engaged incoming trainees in case-based learning sessions. This experience showcases my commitment to creating positive and inclusive learning environments. Adapting facilitation styles to meet diverse audience backgrounds and learning needs highlights my ability to cater to varied educational perspectives.

What else should the Residents Forum know about you?

The biggest challenges I faced as I sought to begin my pathology training in the United States was navigating the complexities of transitioning from an international medical education system to the U.S. residency landscape. Coming from Egypt, I had to adapt to different clinical practices, educational methodologies, and cultural expectations. This transition was further compounded by the need to excel in standardized exams including the USMLE and OET, which required a different approach to study and test-taking than I was accustomed to.

Securing research opportunities was another hurdle. It involved rigorous applications and often required overcoming skepticism about training background. Establishing credibility and proving competencies in a highly competitive environment were continuous challenges.

Additionally, the financial and emotional strain of this journey was significant. Coming from a working-class family, the financial burden of application fees, travel expenses, and relocation costs were daunting. My family's unwavering support was crucial; however, the responsibility of not letting them down added pressure to succeed.

Despite these challenges, my perseverance and dedication enabled me to thrive and achieve my goal of completing my post graduate training in the U.S. as well as to fulfil my commitment to pathology as a specialty.

I have joined pathology residency program in the U.S. due my deepest beliefs and aspirations that both would equip me with ample opportunities and experiences to advance my knowledge in the three pillars of training including clinical, teaching and research. My overall educational objectives and professional goals are deeply rooted in my commitment to advancing the field of dermatopathology in these three pillars of training.

As a pathology resident at Baylor College of Medicine, my passion for dermatopathology has grown through hands-on experience and research. My work on various dermatopathology research projects has equipped me with a robust foundation in methodologies essential for addressing complex dermatopathological questions. My aspiration is to make significant contributions to the understanding and diagnosis of dermatological diseases, particularly by exploring the intricate relationship between skin pathology and underlying molecular mechanisms.

In line with my commitment to dermatopathology, I have been awarded the American Society of Dermatopathologist Research Mentorship Award and Baylor College of Medicine (BCM) Trainee Research Symposium 1st Place award. I aim to mentor future medical professionals, sharing my experiences and insights to help them navigate the challenges of their careers as I have done in my current role as a preceptor for premedical summer program at BCM.
